

MINUTES OF THE REGULAR MONTHLY MEETING OF THE WILCOX COUNTY COMMISSIONERS HELD ON APRIL 1, 2014 AT 6:30 P.M. IN THE COMMISSIONERS MEETING ROOM OF THE WILCOX COUNTY COURTHOUSE.

Chairman Lanier Keene called the meeting to order.

Commissioner Tracy Tyndal gave the invocation.

Commissioner Tracy Tyndal made a motion to approve the minutes as presented. Commissioner David Brown seconded the motion that carried unanimously.

There were no guests with public comments.

The first item of business was the presentation of a Purple Heart Proclamation. There was a conflict so the representatives are going to try to make it next month.

There was a vacancy on the Tax Assessors Board due to the resignation of Richard Moorhouse. Commissioner Tracy Tyndal made a motion to appoint Ms. Evelyn Gordon to fill the unexpired term until March 1, 2016. Commissioner Huck Greene seconded the motion that carried unanimously.

The Eighth Judicial Superior Court budget for 2014-2015 was presented in the amount of \$53,760.66. There being no increase, Commissioner David Brown made a motion to approve the budget request. Commissioner Huck Greene seconded the motion that carried unanimously.

The only item of old business was a vacancy on the MHADDD Board. It was noted that we are having a hard time finding someone to fill the vacancy due the monthly meetings being held 75 miles away. We will continue to work on this.

Commissioner Tracy Tyndal stated he was glad to get the information on the sales ratio.

County Manager Paula Jones Ball gave a brief update as follows:

There will be a pre-construction conference on the CDBG grant on Thursday at 10:30 here at the Courthouse so work should begin soon. Everyone was invited to attend.

Steve Vaughn, Gebcorp, is going to be here on April 10, 2014 at 6:00 p.m. to discuss county retirement.

Ms. Evelyn Gordon has completed the personal property audit for this year.

There being no further business, Commissioner Jowan Johnson made a motion to adjourn. Commissioner David Brown seconded the motion that carried unanimously.
