

MINUTES OF THE REGULAR MONTHLY MEETING OF THE WILCOX COUNTY COMMISSIONERS HELD ON APRIL 5, 2016 AT 6:30 P.M. IN THE COMMISSIONERS CONFERENCE ROOM OF THE WILCOX COUNTY COURTHOUSE.

Chairman Jowan Johnson called the meeting to order.

Commissioner Lanier Keene gave the invocation

Everyone gave the Pledge of Allegiance.

The prior month's minutes from the March 1, 2016 regular monthly meeting and the March 17, 2016 workshop meeting were approved as presented with a motion from Commissioner David Brown and a second from commissioner Huck Greene. The decision was unanimous.

Guests with public comments were as follows:

Mattie Thornton and Deacon McGriff from Antioch Baptist Church were present to request the road to their Church be paved. County Manager Paula Jones Ball explained the tsplst projects and how they were voted on and could not be changed. Thistle Lane is on the second band of paving projects which will be constructed between 2016-2019. They requested the project be changed from Thistle Lane to Bankers Road. It was explained to them projects could not be changed.

Clifton Talley presented the need for 911 markers.

Department Head reports were as follows:

Sheriff Mike Martin was present to discuss the need for a noise ordinance so violators could be ticketed. This will be voted on at the May meeting.

The first item of new business was to vote on the list of projects for the 2016 LMIG additional funds for Safety Action Projects. At last month's meeting, a list was presented that was prepared by Adam Dowdy, Road Superintendent. The projects are as follows:

2 foot Widening

Pitts-Pineview Highway from State Highway 159 to Pineview City Limits
Cedar Creek Road from Pineview City Limits to State Highway 129

Guardrails

Owensboro Road-2 Bridges with no guardrail
Christian Hill Road-1 Bridge and 1 Box Culvert across Cannonville Road
Sibbie Road-1 Section that was hit and is in need of repair
Pleasant View Road-2 Bridges with guardrails that need replacing

Striping

Cannonville Road from Abbeville City Limits to State Highway 233
Sibbie Road from American Legion to State Highway 215
Hatley Road from State Highway 159 to Crisp County Line
Cedar Creek Road from Pineview City Limits to State Highway 129
Cemetery Road from Rochelle City Limits to Crisp County Line

County Manager Paula Jones Ball stated this is additional funding that is available and requires a 10% cash match as with regular LMIG projects.

Commissioner David Brown made a motion to approve the list of projects. Commissioner Tracy Tyndal seconded the motion that carried unanimously.

The next item of new business was the reappointment of Jan Moore to the Wilcox County Board of Tax Assessors. Commissioner David Brown made a motion to reappoint Jan Moore to the board retroactive to March 1, 2016. Commissioner Lanier Keene seconded the motion that carried unanimously.

The final item of business was the fencing of the HVAC units at the Courthouse. The County Manager stated Jimmy Martin is the only person who has submitted a bid. Fred King measured the area but has not submitted a bid. Commissioner Lanier Keene made a motion to postpone any decision until the May meeting in order to try to obtain another bid. Commissioner Huck Greene seconded the motion that carried unanimously.

There were no items of old business.

There were no Commissioner comments.

There was no County Manager report.

There being no further business, Commissioner Tracy Tyndal made a motion to adjourn. Commissioner Lanier Keene seconded the motion that carried unanimously.
